TRANSPORTATION AGREEMENT

WHEREAS the Parents have enrolled their child in a school governed by the Division;

AND WHEREAS the Parents have agreed to provide transportation for their child to attend a Division Educational Program on a regular basis;

NOW THEREFORE the parties hereto hereby agree as follows:

1. This agreement shall be in effect for the period of **September 1, 20XX to June XX, 20XX**.
2. The Parents acknowledge and agree that their child is in need of transportation to attend school. The Parents acknowledge and agree that they will be solely responsible for the means by which the student is conveyed to and/or from school, but they shall take all reasonable steps to ensure that adequate transportation is provided.
3. The personal information collected pursuant to this Agreement is collected under the authority of the School Act that mandates program operations and services offered by the Division and is protected under the privacy provisions of the Freedom of Information and Protection of Privacy Act. Any questions about the collection and use of the information should be directed to the FOIP Coordinator, St. Thomas Aquinas Roman Catholic Schools, 4906 – 49 Avenue, Leduc, Alberta, Telephone (780) 986-2500.
4. The Parent agrees that he/she is entirely responsible for the replacement, maintenance, repair and/or operating expenses for the vehicle used to transport their child to and from school.
5. The Parent shall notify the Division of any change of residence location within five (5) days of such change of residence location.
6. This agreement shall be subject to termination by the Division, immediately upon it receiving notification that the Child is no longer attending school.
7. In consideration of the Parents providing adequate transportation for their child to attend the Division's Educational Program the Division shall agree to pay to the Parents the sum of **\$750, paid monthly at the rate of \$75**, for transportation to and/or from **School Name**. The funding is subject to a retroactive adjustment in December once the transportation funds received for the child by Alberta Education are confirmed.
8. Payment shall be made by cheque to the Parents the week following the last day of every school calendar month.
9. In the event that the Parent is over paid for services not provided, the Parent agrees to return to the Division the amount of any over payment forthwith, upon written demand by the Division to do so.

- 10. The Division shall not, in any way, be liable to the Parent or to any child being transported by the Parent for any and all actions, proceedings, claims, costs, expenses and demands of any nature in consequence of bodily injury, sickness, disease or death sustained by the Parent or their child while riding in, Division or alighting from, any vehicle provided by the Parent.
- 11. This Agreement may be terminated by either party giving notice in writing to the other party, and upon notice being given this Agreement shall terminate on the last day of the same month in which the notice is given.
- 12. The Parents agree that the entering into of this Agreement by the Division fully satisfies and discharges any obligation of the Division to the Parents or the student in respect of transportation.
